- 3) All vehicles purchased must be removed by the close of business on the day of the sale.
- 4) You MUST be 18 years of age to participate in a GSA sale.
- 5) There are NO buyer/bidder registration fees to attend a GSA sale.

I, the undersigned, agree that any bids submitted by me will be subject to the General Sale Terms and Conditions (Standard Form 114C) and any GSA Fleet Special Terms and Conditions applicable to this sale (copies of which I have received or have been made available to me as well as a copy of the Privacy Act Notice).
