

ANAA ORL “Bid Now. Race Later.” Official Rules

NO PURCHASE NECESSARY. HOWEVER, A PURCHASE WILL INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. ELIGIBILITY: “Bid Now. Race Later” (“Giveaway”) is sponsored by AutoNation Auto Auction Orlando (“Sponsor”). The Giveaway is open to all dealers registered with AutoNation Auto Auction Orlando who are at least 18 years old. Employees and officers of Sponsor, AutoNation, and each of their respective parent companies, subsidiaries, affiliates and related entities, advertising agencies, authorized dealers, promotional suppliers, and the immediate family members (spouses, parents, children and siblings and their spouses) or members of the same household (whether related or not) of such individuals are not eligible to enter or win. Void where prohibited.

2. HOW TO ENTER: Each eligible person may enter only by doing at least one of the following activities:

- a. Purchase a vehicle from the applicable week’s featured seller OR
- b. Fill out the entry form on site at AutoNation Auto Auction Orlando (limit one entry per person)

Each vehicle purchase from the applicable week’s featured seller will yield additional entries (no maximum number of entries).

The Giveaway entries will begin on April 2nd, 2026, at the start of the Auction Sale and ends on April 23rd, 2026 at the end of the Auction Sale. No entries will be accepted after such time. Requests must be received within thirty (30) days after the end of the Giveaway period.

3. PRIZE AND ODDS: Three (3) winners (“Winners”) will be selected from a random drawing to receive 2 tickets to the official 2026 Formula 1 Miami Grand Prix race at Hard Rock Stadium in Miami Gardens, FL. The first winner will attend the event on Friday, May 1st, 2026, with the fair market value of the Prize of **\$210.00 USD**. The second winner will attend the event on Saturday, May 2nd, 2026, with the fair market value of the Prize of **\$490.00 USD**. The third winner will attend the event on Sunday, May 3rd, 2026, with the fair market value of the Prize of **\$1,850.00 USD**. No exchanges of prizes with Sponsor will be permitted. Sponsor reserves the right to provide a substitute prize of equal or greater value.

4. WINNER SELECTION AND NOTIFICATION: Winners shall be announced on April 23rd, 2026. Announcement of Winners and instructions for receiving the Prize will be announced at the Auction Sale. Each entrant is responsible for monitoring by either listening in person, watching the online live sale, or by telephone for prize notification. The potential winners have twenty-four (24) hours to claim the prize. Failure to respond within the time period may result in a disqualification and an alternate winner may be selected. Upon the request of the Sponsor, the Winners may be required to return an Affidavit of Eligibility, Release and Prize Acceptance Form, IRS W-9 form, a liability release, and (where legal) a publicity release, all of which must be returned within the time period specified within such materials. Should the Winners fail to

Any portion of Prize not accepted by Winner will be awarded to a substitute winner in accordance with Section 4 above. In no event will Sponsor be liable to award more than the number of prizes stated in these Official Rules.

Failure to comply with these Official Rules may result in disqualification. Sponsor reserve the right at its sole discretion to disqualify any individual suspected of tampering with the entry process or the operation of the Giveaway; or to be acting in any manner deemed by Sponsor to be in violation of the Official Rules; or to be acting in any manner deemed by Sponsor to be unsportsmanlike or disruptive, or with intent to annoy, abuse, threaten or harass any other person. LIMITATIONS OF LIABILITY: The Sponsor assume no responsibility or liability for (a) any incorrect or inaccurate registration or entry information, or for any faulty, failed, garbled or jumbled electronic data transmissions; (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Giveaway; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, computers or providers utilized in any aspect of the operation of the Giveaway; (d) inaccessibility or unavailability of the Internet, the Application (if applicable), or any combination thereof; or (e) any injury or damage to participant's or to any other person's computer or cell phone which may be related to or resulting from any attempt to participate in the Giveaway or download any materials in the Giveaway. If, for any reason, the Giveaway is not capable of running as planned for reasons which may include without limitation, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any
