The undersigned acknowledges that Skipco shall have the right to refuse to transact business with Dealer to modify or release any and all collateral security to extend or change time of payment and to settle or compromise with Dealer without notice to the undersigned and without discharging or affecting the liability of the undersigned hereunder. This guaranty is to be a continuing guaranty and the undersigned hereby waves notice of acceptance of this guaranty and presentment, demand, protest, and any notice on non-payment or dishonor. The undersigned shall be liable as principal debtor and not merely as surety, and the bankruptcy or any assignment in favor or Creditors of Dealer shall not affect the enforceability of this agreement.

This instrument shall bind the respective heirs, executors, administrators, and assigns of the undersigned and shall inure to the benefit of Skipco, its successors, assigns and subrogates.

Where there is more than one signatory to this agreement each signatory shall be jointly and severally liable under this agreement.
