VEHICLE CONSIGNMENT ADDENDUM

This addendum to the Richmond Auto Auction of Virginia, Inc.'s (EAST COAST BOAT & RV AUCTION) Vehicle Consignment Registration is an acknowledgement that the consignor(s) signing below is aware and understands the following regarding any and all vehicles that the consignor(s) may consign to the EAST COAST BOAT & RV AUCTION for subsequent auction sale and that while the EAST COAST BOAT & RV AUCTION will exercise the utmost care for the consignor's vehicles the consignor(s) understands that the following conditions or circumstances may apply to their consigned vehicle(s):

- 1. The vehicle(s) may not be stored in doors and if stored indoors may need to be moved out of doors from time to time while in EAST COAST BOAT & RV AUCTION possession;
- 2. Weather conditions will not impede EAST COAST BOAT & RV AUCTION from conducting its scheduled auction nor any necessary preparation and vehicles may be subject to adverse weather conditions beyond the control of the EAST COAST BOAT & RV AUCTION;
- 3. Potential buyers may wish to inspect the vehicle(s) and may therefore come in contact with them;
- 4. EAST COAST BOAT & RV AUCTION personnel will be required to drive the vehicle(s) from time to time and drive the vehicle(s) through the auction lanes when offered for auction sale;
- 5. It may be required that the vehicle(s) is/are towed. As a result, any special towing instructions and/or towing prohibitions must be made known to the EAST COAST BOAT & RV AUCTION in writing when the vehicle(s) is/are picked up and/or delivered to the EAST COAST BOAT & RV AUCTION;
- 6. In order to operate the vehicle(s) and demonstrate it's capabilities any special operability conditions, processes and methods that will insure proper operation and movement of the vehicle(s) without damage or incident, including but not limited to battery charging and "jump starting," fuel requirements, latches, locks, doors, hoods, and other compartments that are known to the consignor(s) must be made known to the EAST COAST BOAT & RV AUCTION in writing when the vehicle(s) is/are picked up and/or delivered to the EAST COAST BOAT & RV AUCTION;
- 7. In order to recondition the vehicle(s) and prepare it/them for showing and sale any special reconditioning instructions, recommendations and prohibitions regarding the cleaning, washing, waxing of the vehicle(s) exterior, interior, engine compartment and engine must be made known to the EAST COAST BOAT & RV AUCTION in writing when the vehicle(s) is/are picked up and/or delivered to the EAST COAST BOAT & RV AUCTION:
- 8. The interior and exterior condition of the vehicle(s), including its/their operability and any and all restoration work is the responsibility of the seller and the seller will maintain appropriate insurance while the vehicle(s) is/are in EAST COAST BOAT & RV AUCTION possession and until such time as it/they are sold, paid for and title is/are transferred to the buyer(s).
- 9. Unsold vehicle(s) must be gated from the system and picked up in the outlined allotted time for storage. This timeframe will be 1 week or 5 business days after the Sale Date. Additional storage fees will be assessed at a \$5.00 per date rate.
