- All Bidders will be identified by number rather than name. The auctioneer will record sales under your bidder number only.
- The auction is digitally recorded. These terms/conditions apply to all bidders and there are no exceptions.
- All items are offered "AS IS". The seller and Partners Auto Auction make no warranties, either express or implied, as to equipment.
- The Buyer agrees to indemnify and hold harmless Partners Auto Auction from any and all damages, injuries, and/or causes of action which may involve any equipment, vehicle, and / or associated equipment occurring subsequent to the date of this sale.
- Vehicle availability and description are subject to change without prior notice. Used vehicles may be subject to open recalls. For additional information, visit www.safercar.gov.
- It is ultimately the buyer's responsibility to review the car and judge the vehicle's condition before bidding. Partners Auto Auction is not responsible for any errors or omissions contained on these pages.
- Except for items in arbitration, all sales are final. We accept cash, check, and floorplanning. We do not accept any third party checks.
- Partners Auto Auction requires all fees be paid in full upon completion of the auction.
- All purchases must be removed from the auction site by Friday before 12:00 PM (noon). You will be responsible for all storage fees that accrue on any of these vehicles. This is applicable to all buyers, no exceptions.
- Titles for purchased vehicles will be held for pickup in the office. To have titles mailed via FedEx or USPS, please contact the title department and provide the vehicle information. Postage cannot be charged to the account. To mail via FedEx, an account number **must** be provided. If a FedEx account number is not provided, requested titles will be sent via certified mail.
- If a dispute arises, the buyer will pay any/all legal fees.
- Partner's Auto Auction reserves the right to refuse registration to any company, dealer, or individual.
- By registering vehicles for auction with Partner's, the seller/dealership appoints Partner's Auto Auction with a limited power of attorney to empower Partner's Auto Auction and its current staff to assist the seller/dealership with the purchase, sale, and/or transportation of vehicles. With the exception of gross negligence on the part of Partner's Auto Auction, the seller/dealership shall indemnify, hold harmless, and defend Partner's Auto Auction and its current staff against all claims, loss, damage, expense, and attorney fees that Partner's Auto Auction may sustain by reason of relying upon or acting pursuant to such power of attorney.

ARBITRATION POLICY

Frames are guaranteed for 5 working days to the seller and must be returned no later than 12:00 (Noon) the following Friday.

PAYMENT POLICY

We accept cash, check payments and flooplanning.

For all items purchased on Tuesday, payment in full must be received by Friday at 3pm to avoid a late fee. The late fee is \$40.00 and will be applied weekly.

STORAGE AND TRANSPORTATION CHARGES

All vehicles purchased on Tuesday need to be removed from the lot by noon on Friday to avoid transportation and/or storage charges.
