



## **POST SALE INSPECTION POLICY**

The Quincy Auto Auction offers Post Sale Inspections (PSI) as a tool to provide dealers with assurance and peace of mind for both their in-lane and online wholesale auction purchases. A dealer purchasing a PSI has assurance that the vehicle purchased passed a rigorous test, was properly represented, and that the Quincy Auto Auction guarantees that said vehicle meets the dealer's expectations. Further, Quincy Auto Auction stands behind every inspection for 7days after PSI completion.

### **VEHICLE QUALIFICATIONS:**

Green Light vehicles that run at the Quincy Auto Auction or internet channel including OVE and Pipeline Simulcast are eligible for a PSI. Yellow light vehicles are eligible for a PSI excluding the announced or cautionary items.

**Please Be Aware That The Following Vehicles Are Not Able To Be Post Sale Inspected At The Quincy Auto Auction: Which Include but are not limited to:**

**All BMW Models, All Commercial Vehicles, All Vehicles Equipped With Diesel Engines, All Subaru WRX Models, All Mitsubishi Evo Models, All Saab Models, All Audi A8 & S8 Models, All Land Rover Models, All Mercedes AMG-CL-CLS-& G Class Vehicles, & All Porsche Models Are Not Able To Be Post Sale Inspected.**

**In addition, Hand Built Exotic Vehicles, Aston Martin, Bentley, Bugatti, Dodge Viper, Ferrari, LaForza, Lamborghini, Lotus, Maserati, Maybach, McLaren, Panoz, H1, Hummer, & Rolls Royce, Are Not able to Be Post Sale Inspected**

### **PSI Guarantees:**

Depending on the type of Post Sale Inspection selected, all items checked in the Post Sale Inspection are guaranteed for 7 Days, sale day counts as day1.

### **PSI INSPECTION CHECKLIST:**

The following items and areas are included as part of the PSI. Frame/Unibody & Mechanical Inspections check specific items contained within the list. The checklist applies to defects that are non-wear & tear related and singularly \$800 or more to repair or replace.

### **ALL ITEMS CHECKED PER NAAA & QAA Policies**

- Odometer Verification
- Transmission Engages & Functions
- Engine Functions & Operation
- 4X4 System Engagement
- ABS/Brakes Function
- Paintwork Inspected (current model year)
- Inspect for Flood Damage
- Electrical Accessories Checked For Function
- Emission Control Equipment Present
- Front & Rear Differential (excluding vehicles with common differential noise –see NAAA Policy)
- Supplemental Restraint System/ Airbag Check
- Frame or Unibody Structure Checked For Damage
